27 HON TREASURER'S REPORT

The Committee noted that the accounts for 2009/10 had been circulated following the meeting of the Committee in December 2010.

The Hon Treasurer reported that the balances at the bank amounted to c£79,000 and that she had been advised that further sum of £17,000, representing entry fees for the County [swimming] Championships had been banked that day.

It was reported that a further supply of past presidents' badges was required. Mr E J Lyne offered to obtain a quotation for these items from Toye, Kenning & Spencer.

28 REPORTS OF COMMITTEES

1 General Purposes

3 Swimming

The Hon Championships Secretary reported that entries for the County Championships had fallen marginally, from 3360 individual/team swims in 2010 to 3303 in 2011 and that the entry system had operated smoothly. There had been a noticeable fall in entries for the distance events, but the

programmes for other sessions were full. A meeting had been arranged with the management of the Magnet Centre, Maidenhead.

It was reported that the entry material for the "No Frills" Meet had been issued.

4 Synchronised Swimming

The Hon Secretary of the Synchronised Swimming Committee advised that

- A novices' event would held on 11 June 2011, prompted jointly by the Association and Reading Royals SSC.

29 REPORTS OF OFFICE HOLDERS

1 Water Polo Manager

No report.

2 Public Relations Officer

The Public Relations Officer circulated an updated draft of the centenary brochure, and urged those present to supply more historical material about their clubs and swimmers.

It was suggested that the report of the 2010 Inter-County event was not yet available on the website. It was agreed to pass that observation on the webmaster.

3 Swimming Officials' Organiser

The Swimming Officials' Organiser reported that a FINA rules' update session was to be held at Winsor on 17 February 2011.

4 Hon Trophies' Secretary

It was reported that nearly all trophies required for the swimming Championships had been returned, but that, given the time available, it had been decided not to strike any centenary medals for the Championships in 2011.

30 CENTENARY OF THE ASSOCIATION

The Committee discussed, at some length, the organisation of an event to celebrate the Association's centenary on 25 April 2011. Progress had been made with an outline of the speed swimming element of the event, and discussions were continuing in respect of synchronised swimming. However, thus far, it had proved d8fcult to engage clubs involved with diving and water polo.

There was general agreement that the event needed to demonstrate all the disciplines practiced by the clubs in the County and also to involve as many as possible of the clubs comprising the Association. Although there were reservations as to whether those goals would be achieved, it agreed to continue with arrangements for the event, save that a decision would need to be taken by, say, the end of February 2011. Ms H Whittle volunteered her services to co-ordinate the event across the various disciplines, which offer was gratefully received.

31 SUB-REGIONAL DEVELOPMENT PLAN

The Committee noted that no report was yet available about comments on the draft sub-regional development plan, which had been posted on the Association's website for consultation.

32 ASA SOUTH EAST REGION

The Hon Secretary on the meeting of the ASA South East Region Regional Management Board held on6 February 2011. Discipline managers had attended the meeting, and reported on developments within their disciplines. The Board had received a further report on the commissioning agreement between the ASA and the region. The Board had decided to seek a contribution if £3,000 per annum from each sub-region towards the Region's cost (most of the expenditure was borne by the ASA) in employing aquatic officers and the Regional Club Development Officer. It was **AGREED** that the Association would make such a contribution, in the financial years 2011/12 and 2012/13.
