## 6 "COUNTY" OFFICIALS' POLO SHIRTS

The Hon Secretary will propose at the meeting

"That, with effect from 1 April 2023, the Association gives a white "County" officials' shirt to each licensed technical official who volunteers for the first time at one the Association's events - the County Championships, the Masters Meet and the Development Meet - with the expectation that the shirt will be worn when officiating at later County events".

#### 8 REVIEW OF COUNTY GOVERNANCE

The roadshows in the South East Region are arranged for 11 March at the Chilterns Leisure Centre, Amersham and 12 March at K2, Crawley.
