1 MINUTES

3 REPORTS BY DISCIPLINE MANAGERS AND OTHER APPOINTEES

Members will recall that the Board has decided an annual programme for discipline managers and other appointees to attend meeting of the Board.

5 FINANCE

6 COUNTY GOVERNANCE REVIEW

The Board has previously been advised of the County governance review being undertaken by Swim England, and, at its last meeting, appointed a working group to report back to the Board about the achievement of the standard of governance expected by Swim England.

Helen Weeks, Swim England's Sport Governance & Welfare Officer, has been invited to attend the meeting to assist the Board in this exercise.

7 ANNUAL COUNCIL MEETING

The Association's Annual Council Meeting (ACM) is scheduled to be held on 13 July 2023.

Elections will then be held for President, Vice-President (the President in 2024/25), the Hon Secretary, Hon Treasurer and 12 Members of the Management Board. Nominations for those offices should be received by the Hon Secretary by 23 June 2023 (according to the Rules of the Association).

Proposals for changes of Rules etc, for consideration at the Meeting, need to be submitted to the Hon Secretary by 23 June.

Notice of any other motions need to be submitted to the Hon Secretary before 29 June 2023, when the agenda is required to be circulated.

The President has requested that all reports for inclusion in the Annual Report should be sent to her by 1 July 2023.
