8 QUORUM FOR MEETINGS

The Board **NOTED** that, according to Rule 9.1 of the Constitution, the quorum for its meetings was 8 members.

9 OPERATING PROCEDURES OF BOARD

The Board **NOTED** the operating procedures adopted at its first meeting.

10 FINANCE

The Hon Treasurer reported orally that the summer was traditionally a quiet period for Association's finances. That said, the Masters' Meet earlier in the month had made a surplus, and the imminent Development Meet was heavily oversubscribed with entries.

To be confirmed at the meeting of the Board on 15 November 2023 COUNTY WELFARE OFFICER

The Board was reminded that the Hon Secretary had, by name rather than office, been the County Welfare Officer, since the Association had been required to make such an appointment. It had been pointed out, of late, particularly in light of Heart of Aquatics and the importance of welfare, that his appointment was no longer appropriate, given that the Hon Secretary was one of the officers of the Association, and thus intrinsically involved in the Association's management.

Accordingly, the Hon Secretary advised that he would stand down as County Welfare Officer, and indicated that the Board needs to a recruit a suitably qualified person to fill the vacancy.

The Board AGREED to seek a successor to the present County Welfare Officer.

12 REDUNDANT TROPHIES

The Board discussed a note by Peter Button about the redundant [speed swimming] trophies which he had collected from Sam Dyson on 19 August 2023. He described the 6 boxes as containing "a sad collection of dirty, old, unloved and, in many cases, broken cups and other trophies". Peter could not see any point in retaining them, doubting that any of them were worth anything.

Members thanked Peter for taking custody of the trophies and asked him to catalogue and audit the trophies, in case any of them might be of historic significance.

13 DATES OF MEETINGS

The Board **AUTHORISED** the Hon Secretary fix the dates for its meetings for period to September 2024, and the Annual Council Meeting in 2024, following the pattern of recent years.

14 SWIM ENGLAND SOUTH EAST REGION

The Hon Secretary reported on matters discussed at the meeting of the Regional Management Board held on 27 June 2023, covering

- the increased budget, by £10,000, for the current year for coaches' bursaries, because of increased demand;
- the membership fees for 2024 which would remain at the same level as in 2023;
- the adoption of a number of proposals in the field of welfare and safeguarding, eg the welfare function to be discharged by the voluntary Regional Welfare Officer with support from the Region's staff;

- the appointment of Mike Lambert as Swimming Manager, which had been extended to 31 July 2024;
- the minutes of meetings of the regional chairs, the Swim England Board, the Swim England Sports' Operation Committee and the Swim England Annual General Meeting;
- the difficulties facing water polo clubs in securing the number of coaches required to meet current standards.

- Regional Manager, Swim England South East, inviting the County Welfare Officer to attend a forum organised by the Regional Welfare Officer on 19 September;
- Regional Manager, Swim England South East, drawing attention to the advertised vacancies for Regional Chairperson and Finance Director;
- An Events Officer, Swim England, inviting the Association to register an interest in competing at National County Team Championships at Sheffield on 8 October 2024: the following consultation with the County Coach, the Officers expressed such an interest;
- Regional Manager, Swim England South East, forwarding a message from the Chairman of Swim England about the appointment of Andy Salmon as Chief Executive of Swim England, in succession to Jane Nickerson;
- Head of Membership Development, Swim England, setting out imminent work on a swimming results uploader and an update of Integra.

In connection with the National County Team Championships (6th bullet point above), the Board was advised of the sterling work undertaken by Paul Lloyd, and others, to secure the necessary support for the County Coach and the team to participate in the event, despite the continued vacancy for a Swimming Development Manager. The arrangements for the team's travel were explained, and the team was wished every success at the Championships.
